LAME DUCK SEASON IS HERE



WITH 100+ BILLS PENDING, VIGILANCE IS REQUIRED

s you are reading this, Governor Chris Christie's two terms are winding down, while Governor-Elect Phil Murphy's administration is increasingly taking shape. And Senate President Steve Sweeney maintains the helm of the Upper House, while Craig Coughlin (D-South Amboy) is the Speaker-Designate of the General Assembly.

Before we look too far ahead, though, we are also now in the midst of the Lame Duck Session—that short and furious legislative session which began the day after Election Day (November 8, 2017) and concludes at noon on the second Tuesday in January, 2018 (January 9, 2018). During this sixty-two (62) day period, all bills may be considered for hearings, for passage and for Governor Christie's signature or veto.

With five days notice prior to a bill being heard, where weekend days count as a notice day, as an industry we have almost no time to act or to react to critical legislative hearings and key votes. The urgency is magnified by the time crunch - both commercial and familial - associated with the holiday season. From the get-go, we are behind the eight ball.

Heavy Docket

Currently in Trenton, there are over 100 bills pending, at one stage or another, directly impacting alcoholic beverages. Only a handful are beneficial to our industry and the vast majority are unnecessary and counter-productive. Disturbingly, more than a few threaten the very licensing foundation upon which all of our enterprises rest. The bill to

issue thousands of new retail consumption licenses for less than \$10,000 is pending, as is the bill to eliminate the two-license limitation. These two bills, taken alone or in tandem, will cause severe and irreparable economic damage to the New Jersey hospitality sector, possibly resulting in a family business bankruptcy crisis among on-premise retailers and national and global chain store domination in the package store sector.

How will New Jersey's likely legalization of marijuana impact the New Jersey alcoholic beverage industry? Is there a place for existing alcoholic beverage licensees as prohibition is being repealed on cannabis?
